

Our goal is to use the power of life changing mentoring relationships to help youth improve their academic achievement, empower them to make positive life choices, graduate from high school, have higher aspirations, greater confidence, and positive & supportive relationships.





WHY SPONSOR A BIG BROTHERS BIG SISTERS EVENT?

Big Brothers Big Sisters Columbia Northwest never charges a fee to families participating in our programs. That means that all of our operating budget comes from donations, grants, and funds raised at events. Last year, over 30% of our revenue came from our signature events- the Big Futures Luncheon and the Building BIG Bridges Gala. This year we've added a third event, Rappel for a Reason, to appeal to a new demographic of donors.

Big Brothers Big Sisters Programs

Community-Based

The community-based program is traditionally what comes to mind first when you think of Big Brothers Big Sisters. Through this program, adults and children are matched based on geographic proximity and shared interests, and are provided professional support from the Big Brothers Big Sisters Match Support team.

Community-based matches are encouraged to spend time together 2-4 times per month doing low-cost or free activities. This consistency promotes a healthy relationship which supports young people to build self-confidence, think about their future, and have lots of fun!





BIGs+



A Community mentor or "Big" is matched with 15 youth or "Littles." Each Little gets one-on-one time two times each month. One outing will take place in a school setting in the classroom, at lunch, or on the playground. The second outing will take place in the community.

Community Bigs are intentionally chosen for their diverse backgrounds to match our Littles. They are individuals with backgrounds in youth work, mentorship, education, community engagement, etc.



Become a Big

Ignite potential.

As a volunteer mentor or "Big" you will be matched 1:1 with a youth or "Little." You and your Little will get together 2-4 times per month for at least 1 year to share mutual interests, join BBBS agency activities, work on school projects, or just talk about life. The possibilities are endless!

You won't do this alone. Each match has a Match Support Specialist, your BBBS cheerleader who will be with you every step of the way. They will check in, address any issues, help brainstorm outing ideas, and support in any way they can.

There are over 200 youth in the Portland metro area waiting to be matched with a Big. Help us erase the wait by signing up today!

Volunteer Eligibility Criteria

- Be at least 18 years of age.
- Reside in/near and be willing to drive to your Little within our service area
- One-year commitment to the program
- · Have a safe driving record
- Never have been convicted of a felony.
- Demonstrate current appropriate alcohol and drug use.
